Dear Mr. Galvan:

This letter serves as formal notification that the referenced plant is now a Certified Precast Concrete Producer in accordance with ITM 813. Approval was based on the NPCA certification and the submitted Quality Control Plan for your plant.

Your plant has been placed on the INDOT Approved List for Certified Precast Concrete Producers and is approved to supply all precast products required for INDOT contracts. The approval number assigned to your plant is **8586**. Each precast product sent to an INDOT contract is required to include this number, the date of manufacture, the words "NPCA Certified Product", and any applicable Specification required marking. This information is essential to INDOT personnel for verifying compliance with the Specification requirements and processing Material Records.

ITM 813 requires that all materials incorporated into the precast product be approved INDOT materials. Of particular concern is the source of aggregates, which are required to be tested by INDOT and meet the requirements of ITM 203. Please contact Robert Rees, Geologist Supervisor, at 317-610-7251, ext: 232 for information concerning the quality testing of your proposed aggregate source.

All correspondence concerning the certification of your plant is required to be submitted to the Office of Materials Management. These items would include revisions to the Quality Control Plan, additional audit results, or any other pertinent information concerning the certification of your plant.

ITM 813 requires that all precast concrete products be in accordance with the INDOT Standard Specification requirements. Also, several precast products are required to meet the contract Specification requirements that may change for every contract. Attached is a list of the precast concrete products INDOT is currently using, the Standard Specification or Supplemental Specification reference for the product, and the Specification requirements for the precast product. This list of products is the most recent Specification requirement for each precast product; however, Specification requirements are revised and as a Certified Precast Concrete Producer you are responsible for supplying products that meet the Specification requirements for the INDOT contract that the product is sent to.

All contracts let after January 1, 2007 will require that the precast concrete product be supplied by a Certified Precast Concrete Producer. This requirement will be designated in the 2007 Manual for Frequency of Sampling and Testing and Basis for Use of Materials. Contracts let prior to January 1, 2007 will require acceptance of precast products by either INDOT testing or by a Certified Precast Concrete Producer until the contract is completed. INDOT testing will be discontinued for your plant as of the date of this letter. You may supply existing contracts with previously INDOT inspected precast products with an assigned "P" number.

Thank you for your cooperation and attention toward getting your plant into the Certified Precast Concrete Program.
